With heavy hearts, the ERICSA board wishes to announce the passing of Andrew Szymak, a member of the Board of Directors, from Edmond, Oklahoma, on March 6, 2014. Andy served on the ERICSA board since Spring of 2012. Andy was the FIDM coordinator for the State of Oklahoma and a great supporter, attendee and speaker of many past ERICSA conferences. His wife, Christin Semprebon Szymak, formerly of the Vermont child support program, is a former ERICSA Board of Director with many friends still in the organization.

Andy was born in Pasadena, California on December 13, 1962. He graduated from John Marshall High School and received a Bachelor's degree in Political Science from the University of California at Irvine. He continued on to graduate from the Oklahoma City University School of Law. He has been a member of the Oklahoma State Bar Association since 1997.

Andy was a dedicated long-time employee for the State of Oklahoma's Department of Human Services Child Support Enforcement program. He ended his career in the position of program coordinator. He also proudly served as the Oklahoma state representative and board member for national child support conference organizations such the Eastern Regional Interstate Child Support Association and the Interstate Data Exchange Consortium, which allowed him to travel across the country frequently to share his knowledge and expertise with others.

Andy enjoyed travel and was a voracious reader, and was an aviation and history buff. He was also an avid fan of the Pittsburgh Steelers, and was known for wearing his black and yellow

football jacket with matching knit hat during the winter. He loved animals and always doted on his dogs. He is remembered and cherished for his gentle unassuming nature, and his enthusiastic sense of optimism, which inspired those around him.

Andy is survived by his wife, Christin; his daughter and son-in-law, Danielle and Jamie Bailey of Carrollton, Texas; his three step-children, Laurel, Louisa, and Liam Semprebon; his mother Marilyn Szymak, and sister and brother-in-law, Donna and Wes Zuchowski, all of Pasadena, California; and his niece Julie Spencer and her husband Nathaniel, of Manhattan Beach, California.

Andy is also survived by his childhood best friend of over 40 years, Mark Augustyn of Sandy, Utah, the Augustyn family, as well as many other loving friends and numerous cousins hailing from the countries of England, Spain, Holland, Czech Republic, Poland, and Canada.

Why IDEC? North Carolina Chief explains why IDEC is a good fit for families in your state



Dear Colleague,

North Carolina is always looking for ways to make the best use of our resources. We are a full member of the IDEConsortium, benefiting from the internet-based location database and automated batch location as well as Financial Institution Data Matches (FIDM) for delinquent non-custodial parents that we are not provided through the OCSE multi-state matches.

The IDEConsortium is state-owned and operated. States may join as full members or as FIDM Limited Partners through a state contract containing a memorandum of understanding agreement. You may want to consider joining as a Limited Partner in order to boost your collections. States have access to matched data without making any changes to their existing systems or

software or vendor contracts. States may elect to submit all or a portion of their delinquent caseload each quarter as well as have the option to receive their match files quarterly, monthly, or weekly.

Limited partners become reciprocal partners with the IDEConsortium in that each state agrees to process a standard file against the others' financial institutions. In return, the IDEC states are given access to accounts in the participating limited partnership states.

There are approximately 4,000 financial institutions actively participating in the IDEC FIDM process in fifteen states. Matches for the full member FIDM states totaled 545,572 for 4th quarter 2013, with located potential collections totaling \$402,749,996. In addition, the 9 Limited Partnership states from the Alliance Consortium contributed an additional 59,965 matches. The average matched compliance rate for banks reporting was over 99 percent, yielding a high rate of matches and potential collections.
